Consent to Enroll Form

In consideration of being allowed to participate in any way in the Tampa Boy's Basketball Camps, related events, and activities, the undersigned acknowledge, appreciates, and agrees that:

- i. For myself and on behalf of my heirs, assigns, personal representatives and next of kin, I hereby release and hold harmless Tampa Boy's Basketball Camps, The University of Tampa, and any of the officers, servants, agents, or employees and if applicable, owners and leasers of premises used to conduct camp (releases) with respect to any and all personal injury and bodily injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the releases or otherwise that may be sustained by my child/legal ward, while in, on or upon the premises where the camp activities are being conducted, and,
- ii. I as parent/guardian with legal responsibility for this camp participant, do consent and agree to release as listed above all the releases for myself, my heirs, assigns, and next of kin, and agree to indemnify the releases from any and all liabilities incidental to my minor child's involvement or participation in these programs.
- iii. I further agree to indemnify and hold harmless the releases from any loss, liability, damage or costs, including court costs and attorney's fees, that they may incur due to my child's participation in camp activities whether caused by negligence or releases, or otherwise.
- iv. I agree that I am personally responsible for providing accurate information to the camp, staff and facilities used for summer camps related to the COVID-19 virus. I agree to comply with all camp policies and rules, including but not limited to all policies, guidelines, signage, and instructions. Because the camp is open for use by other individuals, I recognize that I can be at higher risk of contracting COVID-19.
- v. With full awareness and appreciation of the risks involved, I, for myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, hereby forever release, waive, discharge, and covenant not to sue Tampa Boy's Basketball Camp, University of Tampa, the city of Tampa, its board members, officers, agents, servants, independent contractors, affiliates, employees, successors, and assigns (collectively the "Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, that may be sustained by me related to COVID-19 whether caused by the negligence of the Released Parties, any third-party participating in Tampa Boy's Basketball Camp, or otherwise, while participating in any activity while in, on, or around the Tampa Boy's Basketball Camp and/or while using any Tampa Boy's Basketball Camp facilities, tools, equipment, or materials.
- vi. I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all costs, expenses, damages, claims, lawsuits, judgments, losses, and/or liabilities (including attorney fees) arising either directly or indirectly from or related to any and all claims made by or against any of the Released Parties due to bodily injury, death, loss of use, monetary loss, or any other injury from or related to my use of the Tampa Boy's Basketball Camp Summer Camp facilities, tools, equipment, or materials, whether caused by the negligence of the Released Parties or otherwise specifically related to COVID-19.
- vii. By signing below I acknowledge and represent that I have read the foregoing Waiver of Liability, understand it and sign it voluntarily as my own free act and deed, including without limitation the Release of Liability and Indemnification requirements contained in this document; I am sufficiently informed about the risks involved in participating in the Tampa Boy's Basketball Camp to decide whether to sign this document; no oral representations, statements, or in documents, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; as legal guardian of the child listed below and I execute this document for full, adequate, and complete consideration fully intending to be bound by the same. I agree that this Wavier of Liability shall be governed by and construed in accordance with Florida law, and that if any of the provisions hereof are found to be unenforceable, the remainder shall be enforced as fully as possible, and the unenforceable provision(s) shall be deemed modified to the limited extent required to permit enforcement of the Wavier of Liability as a whole. This waiver remains in effect until the State of Florida limits all COVID-19 related mandates.
- viii. I/we, the undersigned, hereby certify that I/we, am/are the parent or legal guardian of the camper named below. I/we hereby give permission for the staff of this camp to administer during the period of the camp, appropriate medical attention to my child provided to the camper which are not paid by the camp's excess policy after all other available personal insurance has paid or declined payment.

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement. I have no knowledge of any physical condition that would prohibit my child from participating in the Tampa Boy's Basketball Camps.
